- Procurement Administrative Lead Time (PALT) Industry Days
  - ✓ Established the PALT Updates to Industry in 2011
  - ✓ Each PALT update session provides Industry opportunity to request updates on specific procurements of interest in a “Q&A type” forum
    - No formal agenda, no minutes, no external participation;
    - Open Q&A session not to exceed one hour (0900-1000);
    - Joint multi-functional panel;
    - Industry representatives request update on specific procurements of interest;
    - Information provided limited to status updates pertaining to specific procurements;
    - Government does not provide procurement sensitive information that would violate integrity of source selection process;
    - “Ground Truth” provided; and
    - Over 10,000 Industry partners have attended since inception!
  - ✓ Updated contracting information is posted prior to every PALT on PEO STRI Public Website: [www.peostri.army.mil](http://www.peostri.army.mil)
  - ✓ Implemented “Communications with Industry” Acquisition Instruction (AI) in support of DoD “*myth buster*” campaign
